President

- Responsible for informing Chapter membership of Union programs and supporting Unionwide Leadership decisions.
- In conjunction with Rep, works on strategy and plan to make improvements at the worksite.
- Presides over Chapter meetings and Steward Council meetings.
- May chair committee meetings at the worksite (i.e. Labor Management).

Vice President

- Takes on roles and responsibilities of Chapter President in his/her absence.
- Chairs COPE committee.
- Responsible for coordination, education and mobilization in support of political programs.

Secretary-Treasurer

- Responsible for communications within the Chapter.
- Takes minutes at Chapter meetings and responsible for distribution of Chapter meeting minutes.
